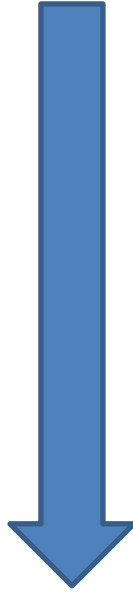



२२. ज्या प्राध्यापकांना भरारी सदस्य पथक/वरिष्ठ बाह्य पर्यवेक्षक /स्थायी निरीक्षक परीक्षा आयोजनाबाबत परीक्षा विभागाकडून वेळोवेळी आदेश प्राप्त होतील त्यांनी संबंधित काम करणे हे महाराष्ट्र सार्वजनिक विद्यापीठ अधिनियम, २०१६, कलम ४८ (४) नुसार बंधनकारक आहे. संबंधित महाविद्यालयाच्या प्राचार्यांनी अशा अध्यापकांना /प्राध्यापकांना नमूद कालावधीकरीता तात्काळ कार्यमुक्त करावे.
